RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

WATER SCHEDULE NO. 1

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service.

RATES (Customers with metered water supply)

First	5,000 gallons used per month	\$17.36 per 1,000 gallons
Next	5,000 gallons used per month	\$10.96 per 1,000 gallons
All over	10,000 gallons used per month	\$ 6.74 per 1,000 gallons

MINIMUM CHARGE

No bill will be rendered for less than \$43.40 per month which is equivalent to 2,500 gallons or:

5/8 inch meter	\$ 43.40 per month (2,500 gallons)
3/4 inch meter	\$ 65.10 per month
1 inch meter	\$ 108.50 per month
1 - 1/4 inch meter	\$ 158.43 per month
1 - 1/2 inch meter	\$ 217.00 per month
2 inch meter	\$ 347.20 per month
3 inch meter	\$ 651.00 per month
4 inch meter	\$1,085.00 per month
6 inch meter	\$2,170.00 per month
8 inch meter	\$3,472.00 per month

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

WATER SCHEDULE NO. 1 (Continued)

RECONNECTION FEE

\$25.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the Utility or a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by their bank due to insufficient funds.

LEAK ADJUSTMENT

\$0.92 per 1,000 gallons is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.
